1. PREAMBLE.

The Lualdi Foundation and the company AVRO SrL intend to organize at the A.V.R.O airfield the VI edition of the AIR EXPO FVG 2024.

The estimated number of the participation aircraft is 120.

The purpose of this document is to provide to the people involved, all the information necessary to have a complete picture of the situation in order to initiate all actions for the correct and safe conduct of the event.

2. OVERVIEW OF THE PROJECT

- a. What is AIR EXPO FVG 2024.It is an aeronautical event that combines the following activities:
 - Static exhibition of aircraft and aeronautical components of regional bodies and institutions.
 - Friulian Aeronautical Technical Schools and Institutes
 - Realization of conference/intervention on aeronautical theme;
 - Exhibition of some manufacturers of aircraft, helicopters and aeronautical accessories;
 - Presence of area food.
- b. Facilities and services

The event area will be set up with structures suited to the needs. In particular, the following are envisaged:

- Preparation of any gazebos of some companies exhibiting gadgets
- Delimitations with barriers and colored ribbons of the areas reserved for the public;
- Refreshment point fully managed by OPEN (bar & Restaurant) able to meet the needs of all those present, the public and people of the organization.
- Health care service adapted to the needs
- Fire surveillance service
- Positioning throughout the area of an adequate number of waste bins.

All the set-ups, once defined in terms of type and number, will be drawn on the floor plan of the event area.

During the whole day the area will be supervised by staff of the organization.

3. TECHNICAL INFORMATION FOR PILOTS

The airfield will be completely dedicated to the AIR EXPO 2024 and for this reason the flight activity of the members will be suspended during the day unless there are proven needs. The airport will be open and will only receive traffic that will notify its participation by sending the PPR request.

4. AREA LAYOUT.

a. Dedicated meeting area

A plan of the area is shown in attachment "B".

b. Areas reserved for external visitors.

There will be a restricted area inside the airfield, and it will be fenced with barriers and/or colored tape.

c. Car parks.

The area provided for cars parking is within the airfield perimeters.

d. Aircraft parking

All participating aircraft will be parked on the airfield outside the visitor area, on the operational movement area. Only crews and authorized personnel with passes will be able to access to this area. The exhibitors will be placed in the areas near the visitors area and secured with adequate covers.

Visiting aircrafts will be parked on the grass adjacent to the runway.

5. STAFF INVOLVED AND BRIEFINGS.

The personnel involved in the organization of AIR EXPO FVG 2024 are listed in Annex C. On 13 July, further staff and civil protection members (if any) will be added who must be indoctrinated on the tasks to be performed.

e. ACCESS TO THE AIRPORT.

The entrance to the airport of external visitors will take place exclusively from the gate set up by the organization.

Airfield Osoppo - Nino Pittini: how to participate.

On the occasion of the AIR EXPO FVG 2024, the airfield will be open to:

1) to general aviation and VDS traffic, whose pilots:

• will have read the "Operating procedures for pilots" published on the website www.avro.it

• have completed and sent to AVRO the **PPR REQUEST that can be found on the website** <u>www.avro.it;</u>

2) the aircrafts that are:

- equipped with an engine;
- have radio equipment for aeronautical use
- 3) to visitors coming by land

b. Procedures for arrivals and departures

c. Stop and assistance

Upon arrival, all pilots and any passengers will be escorted in the exhibition area by the ground staff. Maximum collaboration is required by stopping in the aircraft parking areas for the time strictly necessary to complete the control operations of your own aircraft. In general, during the stay at the airport it is preferable to stay in the areas dedicated to the exhibition.

MOGAS, AVGAS 100 LL and JET A1 are available at the airport. Any additional needs must be coordinated with the organization. For technical and logistical reasons it is suggested to arrive with the fuel quantity available for return. Refueling will only be possible at the end of the day.

e. participation notification.

Participation request can be done via PPR request on the website www.avro.it

The communication must be made as soon as possible and no later than Thursday 11 July 2024.

In consideration of the limited availability of parking areas, the organization reserves the right to "not accept" requests that exceed the established maximum capacity. The arrival date of the application forms guarantees priority in the booking.

f. Coordination

All participants must refer to the AVRO secretariat at the addresses indicated on the WEB site.

g. Procedures in case of emergency.

The normal airport A / I assistance services will be operational at the airport.

Emergency situations during ground and in-flight operations must be communicated on the frequency in use in order to allow timely alerting of emergency vehicles.

h. IMPORTANT

In case of expected adverse weather conditions 13 July 2024, the organization reserves the right to postpone the AIR EXPO 2024. This decision will be made by Friday 12 July 2024 and published on the website.
